1. INTRODUCTION & BACKGROUND

The Housing Development Agency (HDA) is a national public development agency that promotes sustainable communities by making well-located and appropriately-planned land and buildings available for the development of human settlements. As its primary activity, the HDA assembles state, private and communal land and buildings and releases it for development. In addition the HDA provides project delivery support services to organs of state at local, provincial and national level.

Section 7(2) (d) of the Housing Development Agency Act (HDA), Act 23 of 2008 requires the HDA to introduce and manage a land inventory and information system in support of the identification and acquisition of state, privately and communally owned land which is suitable for residential and community development.

The KZN Department of Human Settlements in collaboration with the Housing Development Agency (HDA) has acquired land, namely Ladysmith Extension 18 (Model Kloof) in Alfred Duma Local Municipality measuring approximately 43.4 ha in extent, consisting of 230 un-serviced erven, located in close proximity to the services.

The project aims at reducing the current housing backlog within the Alfred Duma Local Municipality. After completion, the project further promises the potential yield of **1036 units** housing opportunities, comprising of multiple typologies such as affordable (Gap) housing and residential erven (units).

The proposed project will address the housing demand by providing access to housing opportunities for Finance Linked Housing Subsidy House Units and GAP housing units for the middle-income earners within the Ladysmith town. The site is strategically located south and adjacent to N11 which is a primary access to the CBD, connecting the Ladysmith and Newcastle towns.

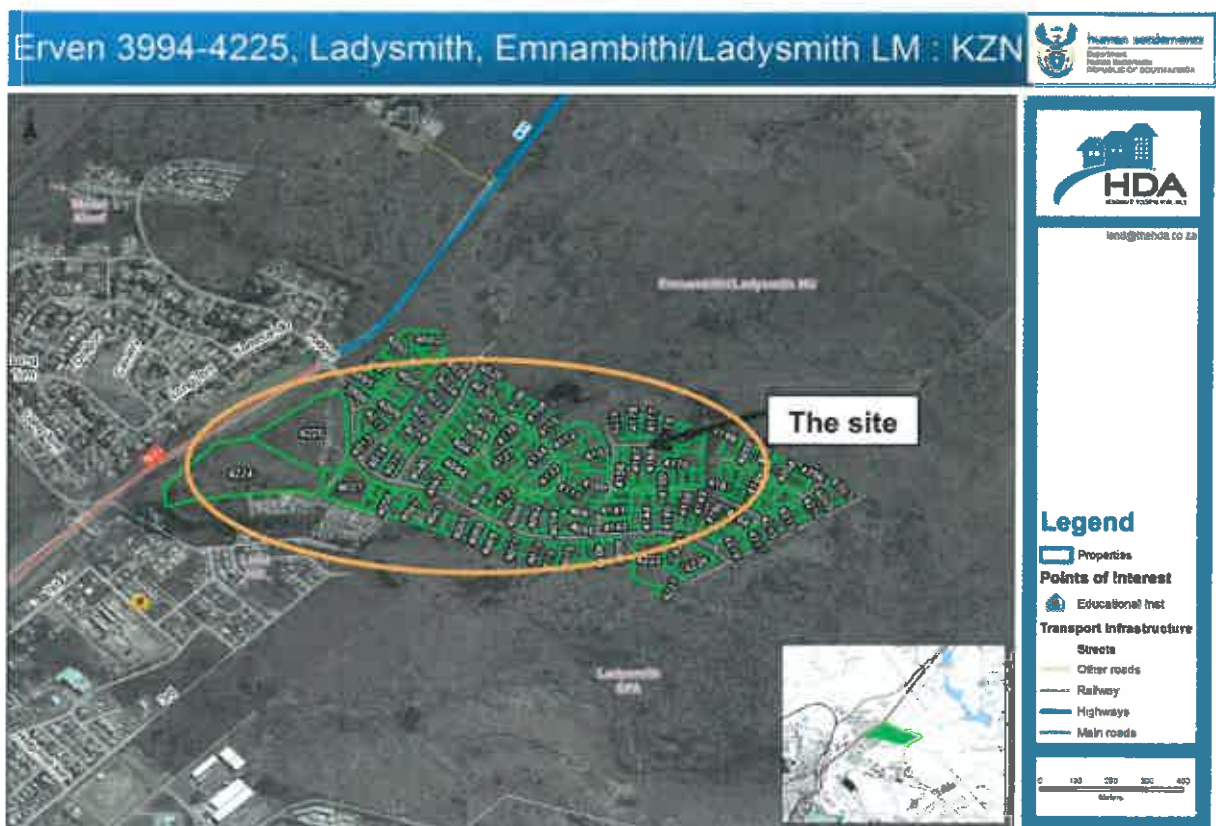
2. PROJECT TITLE

Appointment of a professional team to undertake specialist studies for the scheme amendment and re-layout of General Plan of Modelkloof Extension 18.

3. AREA DESCRIPTION

The study area is located northeast of Ladysmith town and adjacent to N11 National Highway. Furthermore, the site is situated south-east of the existing serviced township, Limit Hill. It is made up of 230 erven with average stand size ranging between 1000m² – 4500m², with the overall site measuring ±43.4 in extent.

Annexure 1, below, indicates the site locality



4. OBJECTIVE OF THE PROJECT

The objectives of the project are two-fold. Firstly, to address the Municipal housing needs and secondly to provide a single development with different income categories catered for; that is, an integrated development that provides for a range of housing options such as BNG/single residential, row housing and bonded housing. Furthermore, the development provides an opportunity to pilot interventions in attaining sustainability through the provision

of social, recreational and economic activities within walking distances of the residential areas that may include:

- Densification of fully subsidised units as row units
- Urban agriculture within sites and commonages in cluster/row houses
- Early Childhood Development site
- Community centre
- Provision of retail and educational sites within the development
- Allowance for a rapid bus transport system, whilst curtailing through traffic
- The creation of 'safe neighbourhoods' to encourage walking, by incorporating cul-de-sacs and other traffic calming measures
- Public open space provision for an open-air gym
- Cycle lanes where possible

A market study/housing survey was completed during May/June 2018, conducted by Urban-Econ Development Economists for the local municipality area. The main aim of the study was to highlight the current housing needs and demand while providing a guideline of the housing typologies to be provided within the local municipality through such housing development projects. The findings and recommendations from the said study states that the proposed development for the Model Kloof should **incorporate an integrated residential development**, with mixed household incomes which includes Subsidised Housing, Rental Housing, Convenient Amenities, BNGs, (RDPs) and Open Market Housing (Private Ownership). The table below, summarises the break down of the recommended typologies;

Settlement Typology	Proposed no of units	% break down
Subsidized housing	743	29%
Social Housing/CRU	1162	45%
BNG/Bonded houses	202	12%
Amenities	6ha	14%

Using the market study recommendations as a guide to achieve an integrated residential development, the services of suitably qualified specialists/professionals are sought to inform the SPLUMA report in undertaking the scheme amendment and the re-layout of the General Plan in line with the SPLUMA read in conjunction with the municipal regulations.

5. SCOPE OF WORK

The appointment of a multidisciplinary team of registered professionals to undertake the following services which includes (but not limited to) the following per specialist studies in ensuring the approval and proclamation of the township;

- a. To prepare a submission and solicit comments from various departments and SOEs regarding the application;
- b. To ensure survey and approval of the layout by the surveyor general;
- c. To ensure pegging of the approved General Plan;
- d. The appointed service providers must take care of all the necessary administrative functions of the application, including, but not limited to: meetings and stakeholder engagements, presentations as approved and agreed to with the HDA;
- e. To ensure that the township is approved and registered by the Deeds Office;
- f. If an EIA process is triggered, a ROD must be sought by the service provider,
- g. If a WULA process is triggered, such approval must be sought by the service provider;
- h. To develop urban design guidelines to be approved and adopted by the municipality;
- i. To develop architectural guidelines to be approved and adopted by the municipality;
- j. To undertake all necessary technical studies and satisfy statutory compliance that is a direct pre-requisite for securing an approval in term of SPLUMA.

Town Planner

A Town Planner will be required as part of the professional team for the overall management and co-ordination of work-streams from the Specialists undertaking the detailed feasibility studies for each of the project areas. The role of the planner will vary depending on the statutory process required for securing development rights, with the primary focus being on land use and statutory planning processes.

The key responsibilities that may be undertaken by the planner include:

- a. Overall management and co-ordination of work-streams
- b. Driving necessary engagements with technical departments and stakeholder
- c. Ensuring the project is executed efficiently according to a programme
- d. The coordination and packaging of all inputs required in the preparation of a Development Framework, Precinct Plan, and Urban Design Framework as may be required
- e. Undertaking a planning assessment, being a technical assessment of the site, and assessment of the current strategic framework giving direction to land use and development objectives for the site

- f. Land Use Planning, involving identifying – in conjunction with any market assessments conducted – the ideal distribution of land use activity across the site, both horizontally and vertically
- g. Statutory Planning, involving identifying appropriate zoning and other statutory tools required to secure a land use management system for the site.
- h. Layout Planning, involving the preparation of a layout for the site. The layout of the site must be founded on sound development principles, goals and objectives developed for the site and in response to the specific needs for mixed use and social housing.
- i. The town planner may be responsible for the urban design development should they be able to demonstrate good competence and experience in this. In this case the town planner must work closely with the architect and urban designer to ensure strong integration between the building envelope, the space between buildings – in particular public space and circulation - and responsiveness to existing development on the edges of the site.

Land surveying study

- a. Withdrawal of existing General Plan
- b. To undertake contour and cadastral surveys to inform the proposed amendment of a township layout, and provide sufficient information for preliminary design of township services
- c. To ensure that all existing services have been covered by servitudes.
- d. To ensure that all erven (as indicated on the layout plan) have been provided.
- e. To ensure pegging, lodge and ensure approval of a General Plan with the relevant authority.

Urban Designer

- a. To work in conjunction with the planner and traffic engineer on a suitable layout for safe neighbourhoods, whilst incorporating elements contained in Item 4 above: Objectives of the Project
- b. To incorporate aspects of best practice in the urban design elements.

Geo-tech Study

- a. To undertake any geotechnical investigations for the proposed township layout amendment;
- b. To submit a detailed report on soil suitability and indicating any challenges with respect to soils stability and suitability that could pose a risk to the establishment of the township;

- c. To provide an opinion whether the subsoil conditions are suitable for conventional strip footing foundations for the various housing typologies.

Electrical Engineering Study

- a. To conduct detail feasibility analysis of the location and availability of existing electrical services (the existing 88 Kv Transmission line traversing the site);
- b. To prepare and design the electrical reticulation system to be incorporated into proposed amended township layout;
- c. To prepare a submission and solicit comments from the relevant authorities regarding the electricity infrastructure (Inclusive of relevant way leave applications);
- d. To ensure that electrical servitudes are captured correctly on the layout plans
- e. To ensure approval of designs
- f. To prepare detailed costing analysis of the proposed reticulation infrastructure and
- g. To prepare proposals for the alternative green or renewable technology that would be feasible for the Model Kloof development project.

Civil Engineering Study

- a. To compile the provisional status quo (existing) condition assessment of the civil engineering service
- b. To prepare and submit the civil engineering report detailing the following requirements amongst others:
 - Preliminary calculations for the wet services infrastructure requirements for the proposed development, with reference to water demand (Including fire water demand), sewerage collection/discharge and stormwater collection/disposal.
 - Providing recommendations on the provision of civil engineering services to the proposed development.
 - Preliminary cost calculations for the provision of planned on-site wet services infrastructure required.
 - Obtain formal confirmation from the applicable municipality about its ability to develop and deliver engineering infrastructure services.
 - Further ascertain estimates for bulk services contribution costs and timelines for the provision of bulk civil engineering services.
 - Proposed engineering services layout e.g. proposed positions of plant, retention and dams and ponds (if any required).
 - Calculation and certification of the 1:100-year flood line. A separate report will be required for the flood-line calculation.
 - Attend all project meetings as and when required.

Transport/Traffic Engineering Study

- a. To conduct and undertake the compilation of a Traffic Impact Assessment report;
- b. Possible traffic engineering layouts and upgrades on the N11 existing Type B2 access and cost implications there off.
- c. Determine the public transport facilities and serving requirements to support the development.
- d. Undertake detailed desktop studies drawing on relevant background information, plans and studies.
- e. Provide guidance to the urban designer and planner on traffic calming and other measures necessary to create safe neighborhoods.

Environmental Study

- a. To undertake the environmental impact study;
- b. To ensure submission and approval of the final Environmental Assessment Report and sought ROD from the relevant authorities.

Conveyancing

- a. To undertake the registration of all newly created erven in Deeds Office.

The following studies should be conducted by the relevant specialists as part of a complete township establishment application. These are:

- Traffic Impact Assessment
- Bulk Engineering Services Report
- Environmental Impact Assessment (if EIA is triggered)
- Geotechnical Report
- Topographical Survey
- Urban design layout
- Cadastral layout plans

6 DELIVERABLES & OUTPUTS

In accordance with the relevant standards and procedures for professional practice and the contracted scope of work, the appointed professional services providers will submit and make oral presentation on the following outputs and ensure that the deliverables are achieved as outlined in an implementation plan to be agreed upon with the client;

- a. Detailed report on the bulk infrastructure, designs and preliminary costing of all services to be included in the implementation of the project.
- b. Detailed township layout plan
- c. Approved Consolidation/Subdivision diagrams and General Plan from the Surveyor General
- d. Record of Decision from the relevant Department
- e. Registration of newly created erven in Deeds Office
- f. Scheme Amendment approval letter from the Municipality
- g. Promulgation of the Scheme Amendment

Further, the professional service provider will submit the work as outlined on the scope of work and in a format that is possible to calibrate and manipulate with other GIS related tools and CAD software (DWG/DXF).

7 PROJECT MANAGEMENT

An inception report with project programme will be required from the service provider, outlining the agreed methodology, implementation plan, expected outputs and deliverables, milestones and timeframes, including a detailed work breakdown structure (WBS), RACI, RBS as well as a risk register and assignment matrix. All these and other project management techniques are to be included in the inception report and agreed to with the client (HDA).

It is the responsibility of the successful bidder to appoint and manage all other subconsultants to undertake all necessary professional studies, with the approval of the HDA.

The Service Provider shall be required to sign a Professional Consultant Services Agreement (PROCSA) with the HDA.

8 OTHER RELATED ANNEXURES

All other related information attained from the any other relevant / responsible authorities, who assisted in undertaking the scheme amendment and the re-layout should form part of annexures of the comprehensive report to be submitted to the HDA.

9 DURATION

The overall project duration is **24 months**, and where any unanticipated hindrances arise, the HDA and the service provider shall review the agreed deadlines. The appointed service provider is expected to submit a project implementation plan within two weeks after appointment/conclusion of contract.

10 REVISION OF COMPLETION DATE

10.1 The appointed Service Provider will be entitled to a revision of the intended Completion Date if delays are caused to the Scope of Services as indicated in 5 above by:

- a. Exceptionally inclement weather;
- b. Acts of God, *vis major*, civil commotion, riot, local combination of workmen, strike or lockout, political interference;
- c. A variation to the Scope of Services as indicated in Section 3 above and any other alterations or variation to the design of the Scope of Services in terms of this Agreement;

10.2 Should any of the circumstances listed in 6.1 above occur, which could in the opinion of the appointed Service Provider cause a delay to the Scope of Services, then the appointed Service provider will:

- a. Give the HDA notice of such circumstance within 5 business days of such circumstance arising;
- b. Take any reasonable practical steps to avoid or reduce the delay.

10.3 Once the delay caused by such circumstances can be quantified, the appointed Service Provider will submit to the HDA full details of such delay within 5 business days of the date on which the delay becomes quantifiable.

10.4 If the appointed Service Provider submits a claim to the HDA for a revision of the intended Completion Date, such claim will be in writing stating separately in respect of each circumstance:

- a. The relevant circumstance referred to in 6.1 above on which the service provider
- b. The giving rise to the claim; and
- c. The extension period claimed in business days and the calculation thereof.

10.5 The HDA shall within 5 (five) business days after being provided with the claim from the Service Provider in terms hereof:

- a. Grant, reduce or refuse the period claimed;
- b. Determine the revised Completion Date;
- c. Identify each circumstance for each revision that is granted or give reasons for amending or refusing such claim.

10.6 Should any extension of time be approved by the HDA, this will be approved without cost.

12. EVALUATION PROCESS

- 12.1 In order to facilitate a transparent selection process that allows equal opportunity to all services providers, the HDA will adhere to its policy on the appointment of services providers.

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the

RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

obligations of the supplier covered under the contract.

1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

2. Application

2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.

2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.

2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.

3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

5.1 The supplier shall not, without the purchaser’s prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.

5.2 The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier’s performance under the contract if so required by the purchaser.

5.4 The supplier shall permit the purchaser to inspect the supplier’s records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or

analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.

10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;

- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take

such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

- 16. Payment**
- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.
- 17. Prices**
- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
- 18. Contract amendments**
- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
- 19. Assignment**
- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- 20. Subcontracts**
- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
- 21. Delays in the supplier's performance**
- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the

supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any

person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which

may be due to him

25. Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
- 29. Governing language** 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
- 30. Applicable law** 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
- 31. Notices** 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
- 32. Taxes and duties** 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
- 33. National Industrial Participation Programme (NIP)** 33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
- 34 Prohibition of Restrictive practices** 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
