This communication is set out in the interest of assisting with clarifications on questions raised by prospective bidders on the briefing session held on 12 July 2024 for the appointment of a service provider to undertake a municipal wide land audit and preparation of development plans for the Canadian Initiative Green Village, within the Kagisano Molopo Local Municipality in the North West Province.

1. Query No 1: Dated 12 July 2024

1.1. I cannot see in the specification or the scope any public participation meetings that need to be held. If we feel or it seems necessary at some stage in any milestone of the project, we will need to cost for it. Will it be taken care by the municipality or the HDA?

1.1 As stated in section 3.16, 4.7, 5.4, 6.11 & 7.4 of the RFP, the purpose of the project is to: "Facilitate all public participation processes (if required)....". Therefore, the project includes costs of public participation.



2. Query No 2: Dated 12 July 2024

2.1 How long is the project duration or will it be up to the service provider to come up with the project management plan?

- 3.1 It terms of project meetings; will the meetings be held in Gauteng or in North West?
- 3.2 Attributes related to, vested, land users/user department, leases, and lessee is this only for municipal-owned properties or all government-owned properties?

- 3.1 The mentioned on the RPF, the project is implemented in Kagisano Molopo Local Municipality, the North West Province. Therefore, all attributes in the GIS database will be captured accordingly where relevant, without any exclusions.
