# NOTES

- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if (applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. #### **SCOPE OF WORK**

#### 1. INTRODUCTION

The Housing Development Agency (HDA) is a national public sector development agency that *inter alia* has the mandate to identify, acquire, prepare and develop suitable land for human settlements. The agency also undertakes the programme and project management for development of housing and human settlements. We carry out our functions in partnership with a range of stakeholders including national, provincial and local government and municipalities, as well as with communities, developers and financiers.

#### 2. BACKGROUND INFORMATION

One of the priorities of the Medium-Term Strategic Framework (MTSF) 2019 -2024 is to ensure the achievement of spatial transformation through multi-programme integration in 94 priority development areas. In view of achieving this target, the Monitoring & Evaluation, Knowledge Management and Research Planning Unit has established a digital capability to evaluate spatial transformation via a Beneficiary Experience Tracking Application (BETA).
