## **1. INTRODUCTION & BACKGROUND**

The Housing Development Agency (HDA) is a national public development agency that promotes sustainable communities by making well-located and appropriately-planned land and buildings available for the development of human settlements. As its primary activity, the HDA assembles state, private and communal land and buildings and releases it for development. In addition the HDA provides project delivery support services to organs of state at local, provincial and national level.

Section 7(2) (d) of the Housing Development Agency Act (HDA), Act 23 of 2008 requires the HDA to introduce and manage a land inventory and information system in support of the identification and acquisition of state, privately and communally owned land which is suitable for residential and community development.

## **2. AREA / LOCATION**

The offices are located at 199 Anton Lembede Street, Durban

## **3. OBJECTIVE OF THE PROJECT**

The objective of the service is to enable the KZN Housing Development Agency to establish its own design capacity. The HDA seeks the services of a suitably qualified team of software professionals/service providers to supply, install and maintain software for a period of five years.

## **4. SCOPE OF WORK**

The appointed team of professionals/service providers are expected to undertake/install the following services which includes (but not limited to) installation and maintenance for a period of five years. Training costs for staff of five people should be also allowed in the quotation. The following modules should be covered in the software supplied:

### **Draughting and Design Centre**

The draughting software shall be either Civil Designer or Autocad or equivalent software able to process the graphical and topographical data in a CAD program plus an advanced digital terrain modelling (DTM) program that has all the required functionality to complete design and produce final drawings.

### **Civil Engineering Design Software**

The civil engineering design software shall be the equivalent of either Civil Designer or Civils3D, and must conform to the following design capabilities:

- AutoCAD or Civil Designer draughting software
- Earthworks design, digital terrain modelling or equivalent
- Roads Design
- Water Supply network design
- Sewer reticulation design
- Stormwater design
- Building Information Management

Bidders must price for five licensed users and allow for a five-year maintenance period

### **GIS Software**

The GIS software must be the same as that currently in use at the HDA head office: ARCGIS.

Bidders must price for five licensed users and allow for a five-year maintenance period.

### **Training on the use of software**

Bidders to include in their pricing the training of five HDA staff on the use of the software. The duration of such training shall be not less than 5 days to a competent proficiency level for the civil engineering software, three days for CAD design and draughting; three days for the GIS

software and two days for the BIM. It is imperative that the training takes place in Durban as no disbursements for trainers/suppliers/service providers will be entertained.

## **5 DURATION**

The expected project duration is **5 years**, dependent on the methodology and maintenance expectations, from the date of receipt of an appointment letter. The appointed service provider is expected to submit a project implementation plan within two weeks after appointment/signature of contract.

## **5. EVALUTATION PROCESS**

Bidders will be evaluated in two stages, mandatory compliance and functionality requirements and in terms of the prevailing supply chain policy applicable to the HDA.

Proposals will be evaluated in terms of the prevailing supply chain policy applicable to the HDA and it should be noted that proposals will be assessed using the 80: 20 formula for Price and B-BBEE as per the PPPFA.

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution.
