- B-BBEE Level 1 status level contributor
- Copy of valid Workmen's Compensation Certificate issued by Department of Labour. This must be submitted for all members/partners in case of joint venture/partnership.

Failure to submit any of the above mentioned documents will lead to automatic disqualification.
