The HDA hereby requests suitably qualified and reputable service providers to submit tenders for:

APPOINTMENT OF A PRE-APPROVED PANEL OF CONTRACTORS FOR CONSTRUCTION OF INFRASTRUCTURE AND TOP STRUCTURE SERVICE TO ASSIST THE HOUSING DEVELOPMENT AGENCY WITH CONSTRUCTION WORK OF VARIOUS HUMAN SETTLEMENTS PROJECTS LOCATED WITHIN VARIOUS PROVINCES OF SOUTH AFRICA FOR A PERIOD OF 3 YEARS (TENDER NO.: HDA/JHB/2016/014)

Bidders that do not comply with the following may not be considered further for technical evaluation:

- CIDB contractor grading designation of 6 or higher.
- NHBRC registration for GB contractors is a must.
- Formal Agreement in case of consortia/Joint Ventures.

Failure to submit any of the above mentioned documents will lead to automatic disqualification.

Proof of payment is required upon collection of the tender documents. No cash or cheques will be accepted by the HDA.

A compulsory briefing session with representatives of the HDA will take place at the Housing Development Agency (HDA), Block A, Riviera Office Park, 6-10 Riviera Road, Killarney, Johannesburg, on 28 October 2016 starting at 10h00.

Failure to attend the compulsory briefing session will lead to automatic disqualification.
